

We offer the opportunity to reflect on and analyse current policy developments in education, and to lead and develop your own areas of interest.

#### Our courses

Kingston University's School of Education offers a variety of postgraduate qualifications in education to suit your needs, including our continuing professional development (CPD) programme and our innovative taught doctorate, as well as our PGCEs in primary and secondary education.

Our portfolio of postgraduate CPD pathways offers critically engaging specialist input and support for your professional development and career advancement. These professionally endorsed courses are designed to provide you with a suitable environment and forum in which to explore and research the educational issues that are currently most relevant and important to you, and to the future of our schools and colleges.

The courses are available to those who work in educational organisations and are suitable for professionals who either have qualifications and/or significant work experience and would like to update and expand their knowledge in particular subject areas.

The CPD programme course tutors are always willing to provide consultative interviews and discussions to prospective students (see the course page for contact details).

#### First-class reputation

The School is consistently rated among the top education departments in the country.

Our last Ofsted inspection recognised Kingston University as one of the country's top CPD providers. This was reinforced in the Centre for the Use of Research and Evidence in Education's (CUREE) most recent survey report, which commented on the high quality of provision, excellent levels of student satisfaction, above-average completion rates, and the impressive evidence relating to the impact of student study and research on teaching and learning in their school settings.

The School's consistently high placing in the annual National Student Survey report also reflects an outstanding level of graduate satisfaction, being based entirely on independent data collected from our students in their final year. We also have one of the most favourable postgraduate student:staff ratios.

In addition, the School of Education has ranked among the top six in the *Guardian*'s annual UK university league table over the past six years, also receiving a 'Value Added' score – which compares students' individual degree results with their entry qualifications – of 10 out of 10.

### Support for international students

If you're thinking of studying in the UK, Kingston University has lots to offer. With students from 150 countries, Kingston is a truly multicultural university. We welcome around 1,500 new international students every year.

Our location provides a great environment in which to experience life in the UK – you'll be living in London, one of the most exciting cities in the world, but in a green and peaceful part of the capital. If you want to explore other areas of the UK or Europe, London's excellent transport links will give you easy access.

#### **Support**

We offer a range of services designed for international students, such as welcome

and orientation events, language support and the International Student Advisory Centre.

We offer a comprehensive scholarship programme for international students, with each scholarship worth £3,500 per year of study. And, if you're an international student from a non-EU country, and you apply in good time and meet our eligibility criteria, we can guarantee you an offer of halls accommodation during your first year at Kingston.

#### **English language**

If your first language is not English, you will need to demonstrate a good standard of written and spoken English as an entry requirement onto our postgraduate courses (see the course webpage for

details). However, before the start of the academic year (ie September), we offer a pre-sessional English course to help you develop the language skills you will need for postgraduate study – see www.kingston.ac.uk/presessional

Once you start your postgraduate studies, you can join the University's free English Language Development Programme.

### On course for success

The combination of knowledgeable academics and expert practitioners at the University gives Kingston a uniquely dynamic environment in which to further your studies and your career.

#### An industry-focused approach

We work closely with local education authorities, schools, colleges and a wide range of educational organisations to ensure you are kept up to date in the changing world of education. This also enables us to shape, inform and evaluate what we do, and offers you the opportunity to gain first-hand knowledge and to network with educational professionals.

#### Partner schools

Our partner schools are generally situated within 25km of the University.

We are a member of the South West London Teachers Education Consortium (SWELTEC), which includes more than 150 schools and four higher education institutions. We also have excellent partnership schools in Surrey, other Greater London boroughs and Hampshire.

Partnership takes many forms, including school colleagues contributing to course design and delivery and the selection and admission procedures, membership of School of Education boards and committees, and receiving trainee teachers on school experience.

#### The latest in classroom technology

The School of Education prides itself on providing the latest in classroom technology. We have invested heavily in modern teaching technology, equipping teaching rooms with the latest ICT and interactive whiteboards to replicate the experience of classroom delivery. Each room is subject based – there is an art room, science lab, etc – and is equipped with all the relevant facilities you will need to practise your skills before taking them into school.



#### Flexible study

We recognise that teachers and other educationalists can't always commit to linear programmes of study, so we have built a considerable degree of flexibility into our programmes; for example, our CPD programmes are modular in structure.

The CPD programme provides short- and long-term courses for the following groups:

- Teachers who want to update their knowledge
- Teachers who have qualified overseas
- People returning to teaching
- People in a support function who want to qualify as a teacher
- Governors or any adults who work in schools and want to learn more about education

The award-bearing programmes (longer-term courses) are assessed through coursework only, and your work will be strongly rooted in the activities of your professional life. Tasks and assignments will require examples drawn from your practice, and course content and your work activities will complement and test out each other.

#### Online resources

Online study is a key element of many of our courses, and you will have access to StudySpace, the University's online learning tool. StudySpace gives you access to learning and teaching resources, multimedia material, discussion boards, wikis and blogs, as well as providing the ability to create your own profile, networks and groups. You can use this environment to study where you want, when you want, from any internet-enabled computer, giving you maximum flexibility.

Further resources are available on 'My Kingston', our student intranet, including:

- classroom resources by subject which link to organisations for teachers, and websites for teachers and children; and
- Education Image Gallery thousands of quality photographic images, which you can use to create classroom resources.

#### Accreditation of prior learning (APL)

Whenever possible, the School of Education allows colleagues entering our CPD programmes to capitalise on learning they have already gained through relevant professional experience, such as short

courses, training sessions or everyday work (see examples below).

Previous M-level study may be considered for APL purposes if it meets the criteria set out by the School. Each application will be considered on its individual merit.

#### APEL portfolio

Kingston University's accreditation of prior experiential learning (APEL) allows you to submit a portfolio showing evidence of prior learning that you have gained through your professional activities. The portfolio can be assessed and may, as a result, provide you with an access route to the postgraduate CPD programme in lieu of standard entry requirements. In some instances, the portfolio may provide you with advanced standing in the programme.

### National College for School Leadership awards and APL

Successful completion of courses such as the Middle Leadership Development Programme (MLDP), Leading from the Middle (LftM) or Leadership Pathways can also be submitted as evidence of APL for the purposes of advanced standing when applying to the award-bearing programme.

Local school partnerships and federations that currently organise and teach these courses are invited to contact us should they wish to discuss how National College programmes might be considered for APL.

#### NPQH and APL

The National Professional Qualification for Headship (NPQH) can be submitted as evidence of APL when applying to the award-bearing programme. This may be considered for an advanced standing of up to a maximum of 60 M-level credits.

#### **Support services**

In addition to the supportive and stimulating study environment provided by the School of Education, you will have access to a range of University support services, both graduate-specific and more-general University-wide services. These include health and counselling, careers and employment, disability and dyslexia, and the Students' Union, as well as the University nursery and chaplaincy. ### **Research in education**

Many of our staff in the School are research active. This ensures that they are in touch with the latest thinking and developments, bringing best practice to your studies.

Research in the School of Education is concerned with the professional development of teachers, generating excellence in teacher education and enhancing interprofessional collaboration and understanding.

- Research focus

  Education research focuses on:

   practitioner research: subject pedagogy, curriculum leadership, school improvement and policymaking;

   development and impact of partnerships and networks in response to changes in the relationship between higher education and schools as providers of teacher education;

   leadership and management in schools; and

   early years education.

#### **Education research seminars**

The School often hosts education research seminars where eminent researchers are invited to present their findings, followed by the opportunity for questions and discussion.

### Campus life

The School of Education is based at the University's Kingston Hill campus, located around three miles from Kingston town centre. Kingston Hill offers you a safe, attractive environment in which to study, with a first-class learning resources centre. It also benefits from good transport links.

#### What is the campus like?

Our spacious, leafy Kingston Hill campus was once a country estate and still retains some of the original landscaped gardens and the large Victorian house. Over the decades, a range of modern buildings has gone up as the campus's functions have increased.

#### Learning resources centre (LRC)

The Nightingale Centre (LRC) at Kingston Hill provides an attractive, modern and airy environment for study. Named after Florence Nightingale (1820–1910), who was a regular visitor to Kingston Hill, the Centre is open 24 hours a day during term time and includes libraries, study spaces and computer facilities. There's even a learning cafe where you can study and socialise.

#### Teaching resources

The Nightingale Centre has every teaching resource you could think of to help you plan your lessons, as well as a dedicated librarian to help you find what you're looking for. The range of educational resources available also aims to reflect current educational thinking and those used in local schools. They cover material from early learning through to A-level.

#### Imaginative literature

From picture books with corresponding videos/DVDs, CDs and even puppets, to children's novels for all ability levels, and from poetry and plays to fairy tales, the Nightingale Centre has no end of imaginative literature to help you bring your classes to life. Also available are journals that provide the latest reviews on appropriate resources for infants and teenagers, offering you added inspiration.

You'll also have access to a range of children's music and nursery rhymes on CD, as well as artefacts and kits that can be used to illustrate historical periods, different religions, science, maths and music. You can borrow CD-ROMs, posters, DVDs and videos. We also have puppets and storysacks, which contain a picture book, non-fiction book, soft toy or puppet and a game or other associated materials.

#### Advice and support

Expert advice and support is available from LRC staff, and the Nightingale Centre provides a base for careers, accommodation and student finance consultations. We also provide information and links to resources, referencing guides, and resources for your subject on the student intranet, My Kingston, as well as information on all the services we provide.

Extra help and information is available for students with disabilities or special needs, and the LRC's Adaptive Technology Room has specialist enabling software and equipment.

#### **Graduate centre**

Our graduate centres provide postgraduate students with dedicated space for private study, meetings and seminars, computing facilities and a social area for relaxing. Postgraduate students can also mix with staff in restaurant areas in the Centenary Room on the Kingston Hill campus.

#### **Travelling to Kingston Hill**

Whether you're travelling by public transport or by car, getting to the Kingston Hill campus is easy. If you're coming by car, the A3 (which connects Portsmouth to London) is close by, making it accessible from a wide area.

Our University bus service connects Kingston Hill to the other campuses, main halls of residence, Kingston train station and town centre. For timetables, see www.kingston.ac.uk/bus. Alternatively, students can use London buses to get to Kingston Hill – there's a bus stop next to the campus (routes 85 and K3, which also stop close to Kingston train station).

Kingston town itself is around 25 minutes by train from London Waterloo station, and Heathrow and Gatwick airports are just a short distance away too.





# Courses

#### How long is each course?

Unless otherwise stated, courses generally run for the

#### FT Full-time courses: 1 year

Full-time study can range from three to five days' per week attendance, supplemented by your own study.

Part-time courses: 2 years
Part-time study often takes place at weekends or in the evenings.

#### **Child Centred Interprofessional** Practice MA

This course aims to address the needs of practitioners working with children, families and young people in any profession - for example, health, social work, education, early years, youth justice and family practitioners. It is designed to facilitate an integrated workforce that can communicate and work effectively across health, education, business, family law, the youth justice system and health and social care.

#### What will you study?

You will critically analyse, question, interpret and evaluate the effectiveness of interprofessional practice when working with children, families and young people (from birth to 19 years). Students will draw on their professional experience together with current research, case studies (local, national and international), which will provide a basis for analysis and discussion. The Capstone Dissertation module enables you to demonstrate proficiency in the design of a research project, application of appropriate research methods, collection and analysis of data, and presentation of results. You will develop the skills and knowledge gained on the course by applying them to the analysis of a specific issue relating to your area of practice via a substantial piece of independent work carried out over an extended period.

#### **Assessment**

Coursework, dissertation

#### **Examples of modules**

Leadership and Management in Different Interprofessional Environments; Child Development (birth to 19 Years); Developing Effective Interprofessional Responses for the Protection and Safeguarding of Children and Young People; Law and Ethics; Capstone Dissertation

#### **Kev features**

- This course is designed for those who work in any area of the children and young people's workforce, and for graduates wishing to develop a career in this area. It can advance professional practice and may lead to accessing new and emerging roles in the wider children's workforce.
- This two-year work-based course is offered on a part-time basis with intensive weekend attendance patterns – 8 to 10 weekends; half a day on Friday and all day Saturday.
- Applicants with prior qualifications and learning may be exempt from appropriate parts of the course in accordance with the University's policy for the assessment of prior learning and prior experiential learning.

#### **Entry requirements**

A good first degree in a relevant area, and practitioner experience at an appropriate level in a relevant field. International students must have an IELTS score of 6.5 overall. See the course webpage for full details.

#### **Doctor of Education EdD**

This part-time programme enables education professionals to undertake a substantial investigation into an area of current professional practice in education, following contextual modules focused on methods and philosophies of educational enquiry, professionalism and teaching and learning. The EdD is offered in collaboration with the University of Roehampton and involves attendance at weekend conferences, tutorials and online learning activities in the preparation of module assignments, which are focused on professional practice.

#### What will you study?

During the first two years of this five-year programme, you will study modules on professional issues, research methods and design, and issues in teaching and learning. Over the remaining three years, you will undertake a research project that builds on the knowledge acquired from the modules and relates to an area of professional practice. You will report your project in a thesis of 45,000 words or equivalent.

#### Assessment

Coursework, assignments, presentations, research project

#### **Examples of modules**

Professionalism in Education; Professionalism and Professional Practice; Educational Research: Philosophy and Practice; Design and Method in Educational Research; Perspectives on Teaching and Learning; Current Issues in Teaching and Learning; Research Project; Thesis

#### **Kev features**

- To complete the EdD you are usually expected to study for five to six years part time, but, where appropriate, you may be permitted to extend or reduce this time.
- The EdD programme is jointly designed and taught by staff with education-related specialisms at the partner institutions, Kingston University and University of Roehampton. You enrol with one institution (usually the one with expertise most closely related to your anticipated research interests) with access to appropriate resources at both institutions.

### **Education** (English Language Teaching) MA

This full-time taught masters course is intended for future educators, teachers and managers in all phases of compulsory and post-compulsory education who wish to develop their understanding of the practice and theory of English language teaching (ELT) to masters level. It is aimed at both first-language speakers of English as well as those for whom English is an alternative language (EAL), whether practising in the UK or overseas. It is particularly directed towards international candidates wishing to teach English in their home countries, but also to users and teachers of English in a broad range of professions.

#### What will you study?

You will be involved in a practical exploration of second language teaching and acquisition (grammar, lexis, phonology; discourse and discourse analysis; lesson planning, micro-teaching, and the design and evaluation of materials), as well as 'world Englishes' and English teaching for diversity and equity, and the teaching of English through literature. An overarching theme is the increasingly important role played by educational technologies and the specific significance of ICT for teachers and learners of English. Both core and option modules are provided so that you can pursue areas of particular interest in more depth, eg teaching practice and classroom observation, oracy and the significance of talk in the classroom, English teaching in England, or the social and cultural contexts of ELT. Following the taught modules, which are delivered over two teaching blocks, you will have the opportunity to conduct a small-scale research project focused on a specific aspect of the programme, supported by a personal project supervisor.

#### **Assessment**

Research project and coursework (including presentations, micro-teaching, discussion and interactive peer review)

#### **Examples of modules**

Principles of Language Learning for Language Teaching, Teaching English Language and Literature; Oracy and English Language Teaching; Social and Cultural Context of English Language Teaching; Observation and Classroom Practice in English Language Teaching; Educational Technologies for English Language Learning and Teaching

#### **Key features**

- You will learn in small, interactive classes and will be encouraged to share and critique each other's ideas. You will also be encouraged to visit local settings and access resources in central London to inform your studies.
- Tutors include professionals with recent experience of English language teaching in both the maintained school sector and higher education settings. Many have extensive experience in practitioner research.
- An MA from the School of Education will help you towards a career in English language teaching and/or management in a wide range of contexts and settings.

#### **Entry requirements**

Masters degree, or equivalent, in education or related field, and a professional role in education or training. International students must have an IELTS score of 7.0 overall. See the course webpage for details.

Our portfolio of postgraduate pathways is designed for graduate educational practitioners in the early stages of their career and/or who are working towards middle and senior leadership roles, and are committed to developing their careers and extending their skills, knowledge and expertise through further work-based practice and academic study. The programme will enable you to deepen your knowledge and understanding of teaching and learning, and to reflect on and improve existing practice. You will explore a range of theoretical perspectives, subjecting these to critical scrutiny and drawing, where appropriate, on practical knowledge and experience.

#### **Pathway options**

The programme includes a number of well-established pathways that are delivered on a part-time basis at the University (Kingston Hill campus) and at locations belonging to approved associate providers:

- Advanced Professional Practice
- Autism Spectrum
- Early Years
- Leadership and Management
- Special Educational Needs and Disabilities See pages 12–15 for more information.

In addition, specialist programmes are taught by qualified staff at Whitefield Schools and Centre in Walthamstow, for example:

- Complex Needs and Learning Difficulties
- Autism Spectrum

Students who successfully complete 60 credits are entitled to the award of Postgraduate Certificate in Education. Students who successfully complete a further 60 credits (120 total) are entitled to the award of Postgraduate Diploma in Education.

Please note: all government funding for professional development is delegated to the heads and principals of schools and colleges. You may therefore wish to apply to your employer for financial support towards the cost of your study.

#### Programme aims

- To encourage and enable you to develop in-depth theoretical and practical knowledge in a range of education-related disciplines and to apply these in their professional setting
- To provide an opportunity for you to develop an authoritative knowledge and understanding of a chosen area of interest
- To provide you with the opportunity to develop and utilise high-level research skills, independently and collaboratively
- To engender a critical and reflective approach to the literature of, and the professional practice surrounding, your chosen pathway within the programme
- To enable knowledge and understanding of the broader dimension of activity associated with educational provision (sociopolitical/economic)

# Education (Advanced Professional Practice) PgCert/PgDip/MA

Newly qualified teachers (NQTs) and early-career teachers face many workplace challenges throughout the early stages of their working lives. This progression route provides valuable support and advice in areas identified as priorities by educationalists. The modules build on the portfolio approach to career development and provide a unique opportunity to link initial teacher training (Stage 1) with subsequent 'thresholds' in your early professional development.

#### What will you study?

You will study and analyse issues in a range of areas pertinent to educational settings, which may include, for example, professionalism; effective learning; behaviour management; inclusion, equity and diversity; leadership and management; working in teams; and stress and time management. Relevant government policy and current initiatives will also be considered from an informed and critical perspective.

In the final stage of the course, you will have the opportunity to carry out a final research dissertation located within the context of professional practice. On successful completion, you will be awarded an MA in Education, with the possibility of a named route.

#### **Assessment**

Oral and written assignments

#### **Examples of modules**

Policy and Professional Practice; Evidence-based Practice; Making Claims to Knowledge; Researching Professional Learning; Research Dissertation

#### **Key features**

- The course is designed to complement and develop your school's coaching and mentoring support. Wherever possible, we structure your learning around your individual needs and those of your school.
- Exemption from Stage 1 of this programme is possible for those who have obtained 60 or more Level 7 credits as part of their PGCE award.

#### **Entry requirements**

Honours degree, or equivalent, with a minimum of one year's experience. Direct entry to PgDip and MA level is possible. See the course webpage for full details.

### **Education (Autism Spectrum)**

PgCert/PgDip/MA

This is one of the few available specialist postgraduate courses for educational practitioners in this field, and seeks to satisfy the increasing interest and growing demand from those who wish to develop their knowledge, skills and understanding of autism spectrum conditions and differences. As well as being designed for early years practitioners, this broad-based course is also suitable for primary, secondary and specialschool teachers. Applications are also most welcome from appropriately qualified support staff, as well as lecturers and other members of the education workforce.

#### What will you study?

You will study the identification, assessment and diagnosis of autism, as well as possible causes and co-existing conditions. As part of curriculum provision, you will consider structured intervention programmes and the nature of autism-friendly environments. In relation to inclusive education, issues concerning school placement, transition and transfer are discussed, including choices and challenges for young people moving into adulthood. In emphasising the need for support for parents or carers and other members of the family, the course also respects the voices of children and young people on the autism spectrum.

If you successfully complete a final research dissertation located within the context of professional practice, you will be awarded an MA in Education with the possibility of a named route.

#### Assessment

Personalised and professionally relevant coursework including a child case study, survey and a small-scale investigation; no formal written examinations

#### **Examples of modules**

Understanding the Autism Spectrum and Implementing Legislation; Accepting a Placement and Providing the Curriculum; Personalising Teaching and Learning and Conducting Assessment; Accessing the Services and Evaluating Provision; Research Dissertation

#### **Key features**

- In helping you to improve your academic qualifications and further your career, the course enables you to reflect critically on current developments in the rapidly expanding field of autism.
- Through conducting personal research projects, you will be able to access the facilities of our comprehensive learning resources centre and share your experience as a member of an academic community.
- You will also be informed about the services of different voluntary and charitable organisations actively working to support children and young people on the autism spectrum, and their families.

### **Education (Complex Needs and** Learning Difficulties) PgCert/PgDip/MA

This pathway is designed particularly for those colleagues working in special educational settings with children whose physical, educational and emotional needs are complex and diverse. The course draws on the expertise and pioneering work in this area of our partners at the internationally renowned Whitefield Schools and Centre. Whitefield's staff share the latest understandings with those seeking to work in support or principal roles in this demanding specialist field.

#### What will you study?

You will study the latest ideas associated with caring for and educating children and young people with multiple conditions and diverse needs. You will have the opportunity to develop a strong theoretical and ethical perspective on this work, and to explore the interprofessional practice associated with these children and their needs.

If you successfully complete a final research dissertation located within the context of professional practice, you will be awarded an MA in Education with the possibility of a named route.

#### Assessment

Written assignments

#### **Examples of modules**

The discussions will reflect a range of important issues – some well researched and established, together with others that are currently emerging. These will cover topics such as foundation stage and KS1 tensions; inclusion, equality and diversity; interprofessional practice and international perspectives.

If you successfully complete a final research dissertation located within the context of professional practice, you will be awarded an MA in Education with the possibility of a named route.

### **Education (Special Educational Needs and Disabilities)**

As a class or subject teacher, middle manager, special educational needs co-ordinator or college lecturer, this course will develop your knowledge, skills and understanding of learning difficulties in children and young people. It is also very suitable for appropriately qualified teaching assistants, as well as other members of the school workforce who provide support, and considers issues in the light of current policy developments and changing provision for special educational needs and disabilities.

#### What will you study?

In considering different perspectives on inclusion, you will study aspects of curriculum planning, teaching, observation and assessment. As well as managing behaviour for teaching and learning, the needs of pupils with specific learning difficulties are also considered. In exploring changing roles in the school workforce, the course emphasises the need for professionals to work together across children's services. It also considers the rights and responsibilities of parents or carers and the involvement of children and young people themselves in their own education.

If you successfully complete a final research dissertation located within the context of professional practice, you will be awarded an MA in Education with the possibility of a named route.

In a rapidly changing educational landscape, new configurations and alliances proliferate. This pathway provides expertise and support for school-based CPD developments of a bespoke nature, enabling individual teachers to gain masters accreditation for group tasks centred on a school's own focused CPD or improvement programmes. These could be in specialist whole-school concerns (pedagogy, school improvement, managing change) or particular subject areas (maths, English, science humanities, arts, ICT). The programme can also support academic study and enhancement for those training to be teachers on work-based training programmes.

#### Course overview

The programme can support 'The Big 6' teaching school initiatives (ITT, CPD, capacity building, nurturing leadership talent, research, and 'school-to-school' support): all potentially see teachers working in their own schools or in collaboration across alliances, at joint projects focused on a school-led, improving system. #### What will you study?

You will gain a sound knowledge of the core subjects of English, mathematics and science, together with the opportunity to explore and develop your understanding of subjects in the wider curriculum, such as history, geography, modern foreign languages, art and physical education. You will also study a chosen specialist subject in further depth (see the webpage for specialisms) and develop the essential skills of communication, planning, teaching and assessment that you will need in practice. You will spend a minimum of 24 weeks in school placements, supported by a school-based mentor and/or a University tutor.

You will focus on one of the following subject specialisms: maths; modern languages (French, German or Spanish); or science (biology, chemistry or physics). Apart from gaining Qualified Teacher Status (QTS) in accordance with government standards, you will also receive the award of PGCE with 60 credits towards a masters degree.

#### What will you study?

Twenty-four weeks of this 36-week practical programme are based in school. You will have assessed practice placements in at least two different schools, enabling you to experience varied types of school. Mentors within the schools, and your University tutors, will provide training, support and guidance during the placements. Your University studies will focus on the teaching of your specialist subject, together with professional skills (eg planning work for pupils, planning for good discipline and control), which will help you become an effective teacher.






# **Travelling to Kingston**


